MINUTES REGULAR MEETING THE GORHAM TOWN BOARD February 10, 2021 7:00pm

The Gorham Town Board held a Regular Meeting on February 10, 2021 at 7:00 pm at the Gorham Town Hall. Present were; Town Supervisor Fred Lightfoote, Councilmembers; William Glitch, Brian S. Case and Richard Malcolm. Chief Operator Water/Wastewater Districts Greg Coston and Town Clerk Darby Perrotte.

Councilmember Jake Chard joined via video/phone conference along with Highway Superintendent Zach Eddinger and Assessor Enza Mineo.

Code Enforcement Officer Jim Morse was necessarily absent.

Other guests in attendance; Town of Gorham Conservation Board Chairman Brett Johnson and his granddaughter Cheyanne, Larry Hastings, John Bero, Town of Gorham Zoning Board of Appeals Chairman Mike Bentley and ZBA Councilmember Tom Amato.

Other Guests joining via video/phone conference; Town of Gorham Planning Board Chairman Tom Harvey, Lynn Klotz, Sally Napolitano, Donna Graham, Ben and Adriane Smith.

1. Call to Order/Pledge to the Flag - Supervisor Lightfoote opened the meeting and led the Pledge to the Flag.

2. Privilege of the Floor –

Town of Gorham Conservation Board Chairman, Brett Johnson, gave a brief update on the Organic Food Waste Pilot Program the Conservation Board is implementing at the Town Transfer Station.

Chairman Johnson said the Board has been in contact with Ontario County regarding grant money for the pilot program. The Conservation Board proposes a three month pilot program. The Conservation Board will seek fifty resident volunteers to begin the program. Containers will be provided to residents.

Chairman Johnson said "The method this would happen is the buckets would be filled and dropped off, a clean bucket picked up by residents. A town worker then empties the buckets into a rented twenty yard water tight roll off. The town supplies labor and cleans buckets. As you hand one in you pick up a clean one so the resident never touches the emptying of the bucket. If we do this on a Saturday the container can be picked up on Monday."

The Conservation Board has been working closely with Vermi-green LLC who is helping them with guidance and recommendations for their start-up program.

Larry Hastings, from Deep Run Homeowner's Association, said "I'd like to bring to the attention of the Board the petition we submitted to request the Town to set up a drainage district for the Deep Run Housing Development for two retention ponds. I submitted to Darby, in September, the required petition and over half the assessed value of the property in Deep

Run wants to go ahead with it. John Bero is with me tonight, he built the whole system, he and his brother, and we're here to answer any questions the Board may have of us at this time."

Supervisor Lightfoote said "To the Board, Enza has brought the document that we need to be able to follow through and what we need to do tonight, and I apologize Larry, I forgot about this stuff, we didn't schedule the public hearing last time because we didn't have this in hand yet so what we do is set the public hearing date tonight. The Board will act on that tonight for our next meeting on March tenth. We will have the public hearing and, unless something comes forward from the public that we need to consider, then we'll probably act on it on the tenth."

Tom Amato, Councilmember, Town of Gorham Zoning Board of Appeals.

Mr. Amato said "I understand you folks are going to discuss a proposal to increase the lot coverage from twenty five to thirty percent. I wanted to come in and say as a resident, and a Board member, I disagree. I don't think it's a good idea for a couple of reasons."

Mr. Amato explained to the Board his reason for disagreement with the proposed change. He believes the whole variance process needs to be tightened up.

The Town Board held a discussion questioning the need for any change to lot coverage requirements in the Lakefront Overlay District, section 31.4.10, of the Town's Zoning Local Law. Planning Board Chairman Tom Harvey said a historical data sheet is a great thing to provide to the ZBA. Chairman Harvey said although he is not an attorney, when you get taken to court, what a court will do is look at your pattern what types of variance you have granted in the past. The court looks at the history, such as; are you not granting one person something that you very similarly granted down the street. Chairman Harvey talked about the tendency of zoning, have they consistently overstepped the bounds of what is allowed in the zoning. The Town Board needs to look at whether they have a tendency to usurp the legislative function of the zoning standards.

Mike Bentley, Chairman, Town of Gorham Zoning Board of Appeals.

Chairman Bentley said although it's an extra step, if the ZBA has the historical variances that were granted, it would be very helpful.

Chairman Bentley said he would like to see the data on what they have granted on a previous variance.

Chairman Bentley said if the lot coverage is moved to thirty percent there are very limited exceptions of where they are going to grant over thirty percent. It will save a lot of red tape paperwork.

Chairman Bentley said "If that's what we are going to do as a Town, we need to be on the same page, thirty is thirty, it's not going to be over thirty percent. I think thirty percent is a great idea if we stick to it and say this is what we are going to do and the limited exceptions are; these three things."

Chairman Bentley talked about non-conforming lots and the views of all the ZBA members. Chairman Bentley said if that's the way we're going to go he agrees with it but would like some clear, precise rules and what the Town Board would think qualifies for an exception.

More discussion was held regarding any need for possible change associated with lot coverage as well as the relationship of the Town's Design Guidelines to the Zoning Code.

Planning Board Chairman Harvey reminded the Town Board that just a few years ago they took a look at the Zoning. They fiddled with the lot coverage, heights of buildings and the Town developed a set of Design Guidelines.

Chairman Harvey said if the Town is talking about increasing the lot coverage, then they need to go back and examine the Design Guidelines to support that change.

Chairman Harvey added "The other part of that we haven't talked about is, when I drafted that Local Law, I didn't know that the Town didn't have an application procedure for a curb cut or driveway permit on town roads. That is something we need to add or could add. From my perspective of the Planning Board there needs to be some coordination between Highway Department and Code Enforcement. I don't care who takes the application, who handles it, who makes the determination what things have to go to Planning Board for site plan, what things that the Highway Superintendent can approve but somebody has to sign off on it and say it meets the Access Management Local Law. The Town needs to be consistent. We can't have the Planning Board refusing somebody a curb cut permit and find one on a Town or County road that doesn't comply. Fred is well aware the lengths we went through to get a nonconforming one that was put in by the County taken back out. I t's all about safety and protecting your resources. It's also about treating everybody the same and fairly."

Many residents had questions regarding the proposed lot coverage percentage change. The Board discussed these changes.

Supervisor Lightfoote informed everyone that this is just at the discussion stage. The Board will make changes through a Local Law which requires proper notification and public hearings.

RESOLUTION #3-2021 TOWN OF GORHAM LONGEVITY RATES

Employee Longevity Pay Rates

Whereas: The Town of Gorham Examines and makes annual changes to the Town's employees base pay rates when the Town Board deems it appropriate and necessary. Any base pay rate changes are identified during the Organizational Meeting of the board. Any base pay changes identified by the board shall take effect on January first of any given year, and;

Whereas: The Town of Gorham realizes the additional value provided by the additional experience as well as the institutional knowledge that are provided by our employees with a longer history of employment with the town, and;

Whereas: The Town of Gorham has used a longevity pay schedule for compensation for town employees for many years, and;

Whereas: There has been confusion regarding the dollar amount as well as the years in service steps identified for after which employees are to receive a pay increase, and;

Therefore: The Gorham Town Board hereby authorizes and requires the following table to be the official table to be utilized for additional employee compensation for the calendar year 2021, and;

Therefore: All versions of the Longevity schedule previous to February 10th, 2021 are to be considered null and void. All eligible employees shall be paid according to the schedule approved for use for any current year and identified at the annual organizational meeting, without regard to previous agreements, and;

Therefore: The following Table is to be utilized for consideration for all eligible employees with any changes to be made starting on the first day of the pay period immediately following any employees anniversary date.

e. Proposed New Highway Building and Proposed Library Addition is put on hold. The Board will revisit both proposed projects in six months. Supervisor Lightfoote said he will keep the engineer and the bond company updated on the hold.

7. Privilege of the Floor –

Sally Napolitano, Lake Drive resident, asked about the tax cap override for the 2022 budget. The town puts the override limit in place before the budget process.

Mrs. Napolitano said "Speaking as a taxpayer I'm not seeing a lot of effort on the town's part as far as tightening your belt. Now you've passed a town tax. I'd be interested in where the town has made efforts to cut their budget."

Supervisor Lightfoote said he has been working on a document for several months that will help explain the need for implementing a town tax.

Councilmember Glitch said the last few years he has asked that our elected officials not take an increase in salary. For the year 2020 Councilmembers did not receive an increase. For 2021, none of the Town's elected officials received an increase in salary. The new truck for highway is on hold. Councilmember Glitch said there are cuts taking place that might not be clearly visible.

Lynn Klotz, Lake Drive resident, agreed with Mrs. Napolitano. It would be good for Supervisor Lightfoote get the document done.

Mrs. Klotz wanted to make sure Kevin Olvany is involved with the changes to Lot Coverage and she does not agree with an increase in lot coverage from a lake friendly perspective.

Donna Graham, County Road 11 resident, offered a suggestion to have the reports of town officials put on the website or attached to the Town Board minutes every month.
