c. Letter of Support to the Town of Romulus and resolution opposing the proposed incinerator.

Town of Romulus Attn: Supervisor 7073 Ovid Depot Road Ovid, NY 14521 Dear Supervisor,

It has come to our attention that Circular EnerG and the State of New York are attempting to build a trash incinerator plant in your town. For the reasons outlined in the included resolution, we feel that this incinerator will have an adverse effect on our community, including; a decrease in tourism, increased air pollution, and increased commercial traffic as dozens of tractor-trailers haul tons of garbage from around our State through our streets on a daily basis.

It is our sense as representatives of local government, that while input from neighboring towns, the state and the company, should all be evaluated and weighed, ultimately this is a towns home rule decision. TOWN OF GORHAM RESOLUTION NO. 13-2018 OPPOSING WASTE-TO-ENERGY PLANT PROPOSED FOR FORMER SENECA LAKE ARMY DEPOT SITE

WHEREAS, Circular EnerG, LLC submitted an application for a Special Use Permit in order to construct a waste-to-energy plant on 39.4 acres of land at the former Seneca Army Depot in Romulus, NY; and

WHEREAS, Operations of said proposed waste-to-energy plant would involve importation of up to 2,640 tons of municipal solid waste (MSW) per day to be burned to generate 25 to 50 Megawatts of electricity, involving shipping of up to 176 tractor-trailer loads of MSW per day on local roads or up to 30 rail cars of MSW through the City of Geneva per day, and create a major new source of air pollution in the Finger Lakes Region; and

WHEREAS, This Board has serious concerns over the negative environmental impacts associated with said proposed waste-to-energy on Finger Lakes Tourism, quality of life, water quality, air quality and thus the negative impact these would have on the economic vitality of the Finger Lakes Region's tourism and agriculture industries, and

WHEREAS, This Board is aware that the Special Use Permit application before the Town of Romulus Planning Board for said waste-to-energy facility has been withdrawn and that Circular EnerG, LLC has stated its intent to submit an application to the State Board on Electric Generation Siting and the Environment for said waste-to-energy facility under Article 10 of the Public Service Law of the State of New York; and

WHEREAS, The Planning and Environmental Quality Committee recommends adoption of this resolution; now, therefore, be it

RESOLVED, That the Gorham Town Board does hereby oppose the Circular EnerG, LLC waste-to-energy plant construction proposal at the former Seneca Army Depot site; and further

RESOLVED, That the Gorham Town Board intends to submit substantive comments to each State and Local Agency involved in the event an application to construct a waste-to-energy facility is made by Circular EnerG, LLC at the former Seneca Army Depot; and further

RESOLVED, That certified copies of this resolution be sent to Governor Cuomo, State Senator Helming, State Senator Funke, Assemblyman Kolb, the New York Association of Counties, the Intercounty Association of Western New York, the Seneca County Board of Supervisors, Romulus Town Board, Town of Romulus Zoning Board of Appeals, Romulus Town Planning Board and the State Board for Electric Generation Siting and the Environment.

d. Hire Deputy Building/Zoning Officer

8. Privilege of the Floor: Mrs. Lynn Klotz, Councilmember on the Town of Gorham Conservation Board, asked about the commercial dumping at the Transfer Station.

Mrs. Klotz said "Several months ago there was discussion about commercial landscapers dumping at the Transfer Station. I think the agreement was we were going to leave it as it was for 2018 and consider changes for 2019, did I miss that discussion?"

Supervisor Lightfoote said "We didn't have that discussion yet, there is a lot coming up in the next few months. We know we need to have a complete redo of what our policies are at the Transfer Station."

Mr. Brett Johnson, Chair of the Conservation Board, said he has asked Town Clerk Darby Perrotte, while she is selling Transfer Station permits, to question residents on the basis of whether or not they would utilize organic composting at the Transfer Station. Also whether or not they would embrace the idea of vermiculture. Mr. Johnson suggested some type of flyer or questionnaire/survey that residents could fill out regarding that type of recycling at the Transfer Station.

Supervisor Lightfoote said we will work on something formal to put out to residents.

9. Executive Session - Town of Gorham v Cregg and to discuss matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation.

On the motion by Councilmember Chard, seconded by Councilmember Glitch, the Board entered into executive session at 8:37pm.
